


Follow-Up Appointment within 7 days









- Consistent data entry
- Completion of training for current team members
- Computer based learning (CBLs) new team members
- Patient education (discharge instructions)
- Post birth warning signs
- Started collaboration with ER on post birth warning signs
- Now have a code alpha (Any OB emergency)
- Maternal hypertension protocol

Challenges & Barriers

- Previous data had a glitch may need to go back a reassess prior months for accuracy
